SECTION 3: HAZARDS IDENTIFICATION

STABLE UP TO 110°C / 230°F. HEATING ABOVE 110°C / 230°F RESULTS IN AN EXOTHERMIC DECOMPOSITION WITH RAPID RELEASE OF CO2 GAS. AVOID CONTACT WITH OXIDIZERS. THIS MATERIAL IS ACIDIC. CONTACT WITH BLEACH, SULFIDES OR CYANIDES WILL LIBERATE TOXIC GASES. HYDROGEN GAS MAY BE RELEASED UPON CONTACT WITH CERTAIN METALS. NON FLAMMABLE AND NON COMBUSTIBLE.
